CRA Public Notice


Under the Federal Community Reinvestment Act (CRA), the Federal Reserve Board will evaluate our record of helping to meet the credit needs of the community with safe and sound operations. Certain information about our operations and CRA performance is required to be made available to the public. Upon request, this information along with the following information will be made available to you within five calendar days of the request: 1) a map of our assessment areas; 2) information about our branches in these assessment areas; 3) a list of services we provide at our branch locations; 4) our lending performance will be made available when an evaluation has been completed; 5) written comments that relate to our CRA performance will be made available when received.

The Federal Reserve provides a list at least thirty days prior to the start of each quarter that details the banks scheduled for CRA examination. The referenced website can also be used to submit written comments about our performance to meet community credit needs. Your comments along with our responses will be considered by the Federal Reserve System in evaluating our CRA performance and may be made public.

Effective January 1, 2018 the Home Mortgage Disclosure Act (HMDA) data about our residential mortgage lending are available online for review. The data shows geographic distribution of loans and applications. Information including ethnicity, race, sex, age and income of applicants and borrowers is made available for loan approvals, denials and withdrawals.

This data is available online at the Consumer Financial Protection Bureau's website, (https://www.consumerfinance.gov/hmda), beginning with calendar years 2022 forward.












Pulaski County Census Tracts
